4. The user shall be deemed to have received the bill and the contents thereof once MTN Service Provider systems indicate that the bill has been forwarded by way of electronic means to the user. Accordingly, evidence of electronic delivery notification shall constitute prima facie proof that such bill has been forwarded to the user.
5.
